TRANSFER GUIDE!

The process of transferring the title into your name will vary depending on whether you live in the State of Florida, outside Florida, or if you are exporting the vehicle.

REQUIREMENTS FOR A TRANSFER

- Valid ID, passport, or U.S. driver's license.
- The original title properly signed.
- Bill of sale and/or purchase invoice of the vehicle (this document will be sent via email and must be signed by the buyer; we will ask for your full name, phone number, email, and current address).
- Vehicle insurance (if requesting a license plate).

TYPES OF TRANSFERS

- Simple transfer: Title of ownership in your name only.
- Transfer with new license plate: Title of ownership in your name plus a new license plate to drive in the U.S.
- Transfer with license plate assignment: Title of ownership in your name plus the assignment of an existing license plate in your possession to drive.

PROCEDURE

WITHIN FLORIDA

We must process the transfer for you at the Tag Agency we have assigned.

You must send us the previously explained documents.

OUTSIDE FLORIDA

You must carry out the transfer at the Tag Agency closest to your location.

You must take the previously explained documents.

WITHIN FLORIDA

No transfer is necessary (depends on the country, ask before).

You must have the purchase invoice plus the vehicle's title of ownership.

EXPENSES TO CONSIDER

Taxes: these vary depending on the state you are in; in Florida, it is 7% of the vehicle's purchase value.

Permanent license plates: if new, these vary depending on the vehicle and range from \$200 to \$500, and if you already have one, the assignment is approximately \$150.

Temporary license plates: it lasts for 30 days and costs \$30 (note that it can only be assigned to the final buyer and only works for vehicles with a clean or rebuilt title).

Administrative fee: in case you are in Florida, the entire transfer process costs \$100.

Document shipping: you have the option to collect the documents in person at our offices in Doral, otherwise, shipping them costs \$20.

POTENTIAL ISSUES

- If you are outside Florida, your location's DMV may request an additional document; if so, you must notify us to support you.
- Sometimes the auction forgets to send a document that should be attached to the title, like an affidavit or lien release; if this is your case, you must notify us to support you.
- In case the title is lost by the auction, UPS, or in any other way, you must notify us to support you.
- Remember that we are managers in the auction purchase, so it is not within our power to handle DMV or auction tasks, but if any issues with the documents occur, we will support you until a solution is found.
